Nonpayment of full deposit is considered a forfeiture of class participation privileges.
2. All deposits and payments are nonrefundable, no exceptions.
3. Tuition into the House of Truth Wrestling School is \$2,430. You have two payment options.  
A: Payment Plan - \$1,000 deposit, then payment of \$130 is due on Monday of the second week of class and every Monday following for 11 weeks. All payments are due by the last day of class signed up for.  
B: Pay in Full – **Make a one-time payment of \$2,000 and receive a \$430 discount!**  
(Deposit or one-time payment is due 7 days prior to the first scheduled date of class)
4. Payments can be made by check or cash in person. Please make check payable to **Martin Krcic**.
5. All payments should be sent to **Martin Krcic, PO Box 1371, Sterling Heights, MI 48311**. Please include this completed contract with your payment. Contract must be received and signed prior to the start of class.
6. Under extenuating circumstances, class may be rescheduled at the trainer's discretion.
7. Students affirmed participation is voluntary and will knowingly assume all risks. Any injuries sustained are not the responsibility of the House of Truth Wrestling School, its trainer Martin Krcic or any and all participating in training. Students release the House of Truth Wrestling School and it's trainer of any liability.
8. All students must be 18 years of age or older to participate. Any student under the age of 18 years of age must have written parental consent.
9. Should any student decide to be removed from class for any reason, they may return to complete training within 1 year of class start date on this form for a return fee of \$100. After 1 year the return fee is \$1,000.
